

WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT

I wish to participate in The Soap Factory Haunted Basement 2013 program. I understand that, as a part of this event I will be entering in to the basement of The Soap Factory building, in exchange for my monetary contribution. In so doing, I HEARBY ASSUME THE RISKS OF PARTICIPATING IN THIS EVENT AND AGREE TO FOLLOW THE HAUNTED BASEMENT'S RULES.

**I understand that there are risks and dangers inherent in participating in The Soap Factory Haunted Basement including, but not limited to, risk of personal injury and damage to clothing or possessions resulting from walking through a basement area in darkness, flashing lights, strobe lights, low frequency sound, electric shocks, strong smells, concentrated fog/smoke, physical contact, strenuous physical activity, projectiles, dust, dirt, disturbing and adult content.**

In consideration for allowing me to participate in The Soap Factory Haunted Basement 2013, I hereby agree to indemnify and hold harmless the event organizers and other parties set forth in the following paragraphs, all as set forth below.

I also assume all risk of being here, and I waive any right to compensation for any and all injuries occurring at the event. This assumption of risk and waiver will fully prevent me, my child(ren), my heirs, successors and assigns anyone else acting on my behalf or on the behalf of my child(ren) from making any claim for injury, death and/or damages or other losses (economic or non-economic), even if such claims are caused by the negligent acts or omissions of the persons I am hereby releasing or are caused by the negligent acts or omissions of any other person or entity. I fully release The Soap Factory, its directors, agents, volunteers and employees from any such claim.

I also agree to indemnify and hold property owners and their respective directors, agents, employees and volunteers harmless from any damages or suits from any persons for acts or omissions by myself or any related party in connection with my participation in The Soap Factory's Haunted Basement 2013.

I acknowledge that I have read this Waiver Agreement and that I understand the words and language in it. I have been advised of the potential dangers incidental to participating in The Soap Factory's Haunted Basement 2013 and I am at least eighteen (18) years of age and fully competent.

**The Haunted Basement 2013 Rules:**

- 1) NO admittance if you are under 18. IDs will be checked at the door.
- 2) NO Alcohol. NO admittance to intoxicated individuals. The Soap Factory reserves the right to refuse admission, as well as the right to insist a patron leave the premises.
- 3) NO touching any of the exhibits, props or performers. The Soap Factory determines patron compliance and reserves the right to eject any patrons at our discretion.
- 4) For your own safety and comfort, you MUST have appropriate clothing to navigate through challenging and messy environments: no high heels or flip-flops. Inappropriate shoes will be checked at the door.
- 5) All bags, coats, phones and other loose items will be checked at the door. All patrons are required to wear specific, provided clothing and protective goggles. A list of recommended attire is available at soapfactory.org
- 6) Groups of 4 will be admitted into The Haunted Basement every 3 minutes. Each patron must have a ticket.
- 7) Patrons agree to the use of photography and video recording in The Haunted Basement and authorize the release of those photographs for publication.
- 8) No re-entry.
